Program Objectives:

- To construct stone crossings on intermittent or permanent streams to reduce sedimentation from livestock
- To allow vehicles and equipment to cross watercourses without causing unnecessary soil erosion
- To protect surface water quality and fish habitat

Eligibility:

- The registered landowner must make out all applications
- The project must be in the SRWD
- Priority will be given to projects where steams/creeks flow on a year-round basis and livestock access is required

Cost Sharing:

- The SRWD will pay 75% of the total project cost up to a maximum of \$2500 for stone crossings/riffle structures
- Sub-Districts will provide on-going maintenance on crossings at their discretion

General Terms & Conditions:

- The annual projects resulting from this program will be subject to funds appropriate
- Subject to the above terms, the Agreement shall become effective and shall be binding upon both parties until terminated
- Said termination shall take effect as of five years subsequent to the effective date hereafter described
- Failure to comply to any of the said terms and conditions may negate the landowner's eligibility to participate in further SRWD programs.

Landowner Responsibility:

- Complete and sign proper application in full before deadline
- Provide consent of entry onto property for inspection and construction
- Provide sufficient room for construction;
- Not alter, change, remove or modify the project without written consent of the District for 5 years;
- Be responsible for reasonable maintenance of the project
- Pay the agreed upon amount as set forth in the SRWD application upon receipt of an invoice from the SRWD.
- Indemnify and save harmless the SRWD from any and all actions, claims, suits, damages, injuries, or other loss arising as a result of the construction, operation, or maintenance of the project.

Watershed District Responsibility:

- Apply for any necessary permits prior to commencement of construction activities
- Arrange for the necessary equipment/contractor and supervise the project to ensure it meets construction standards
- Invoice the landowner for the appropriate amount upon determination of the total project cost
- Reserve the right to reasonable access to project site for the purpose of inspection, and of educational tours
