- To improve the quality of water provided to livestock using remote watering systems
- To protect surface water quality
- To promote the importance of water quality
- To reduce the loss of livestock by eliminating access to water sources
- To protect fish and wildlife habitat

Eligibility:

- The registered landowner must make out all applications
- The project must be in the SRWD
- System must be situated near a natural waterbody
- One system per farm location

Cost Sharing:

- The SRWD will cover 50% of the total project cost to a maximum of \$5,000 (may include pump, pipe, fittings, trough, tank, etc.)

TERMS AND CONDITIONS

General Terms & Conditions:

- The annual projects resulting from this program will be subject to funds appropriate
- All types of remote watering systems are eligible for assistance
- Landowners that have received assistance from this program since April 1, 2002 will be ineligible for any new projects from this program

Landowner Responsibility:

- Complete and sign proper application in full before deadline
- Provide consent of entry onto property for inspection
- Install remote watering system project within the SRWD in the year of application
- Shall not sell, trade, or exchange remote watering system materials for a minimum of 5 years
- Not alter, change, remove or modify the project without written consent of the SRWD for 5 years
- Be responsible for reasonable maintenance of the project
- Failure of a landowner/renter to meet Landowner Responsibilities may negate him/her from other Conservation District programs

Watershed District Responsibility:

- Reserve the right to reasonable access to the project area & photos for tours or to inspect the project
- Provide recommendations on various types of remote watering systems or refer the landowner to the appropriate technical staff to assist with the selection of a suitable remote watering system
- Inspect completed project
